The prescription drug section of **capbluecross.com** will have a new look in 2020. But you will continue to find in-network pharmacies, search for drugs covered by your plan, compare costs of medications, and more!

#### **HOME DELIVERY**

Starting January 1, AllianceRx Walgreens Prime will be your plan's new home-delivery pharmacy.

- If you're a current Capital BlueCross member and CVS Caremark mails your prescription drugs to you, your open refills will automatically transfer to the new home-delivery pharmacy on January 1.
- In the new year, call AllianceRx Walgreens Prime at 855.924.8421 or visit alliancerxwp.com/homedelivery to set up an account, provide payment information, and to order a refill. You also can log in to your secure account at capbluecross.com and choose "Start or Manage Home Delivery."
- Please allow 14 days for delivery.

Note: If you already receive specialty drugs from AllianceRx Walgreens Prime, you won't need to set up a separate account.
