

SUMMARY ANNUAL REPORT

For LAFAYETTE COLLEGE HEALTH AND WELFARE PLAN

This is a summary of the annual report of the LAFAYETTE COLLEGE HEALTH AND WELFARE PLAN, EIN 24-0795686, Plan No. 509, for period 07/01/2020 through 06/30/2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with CAPITAL ADVANTAGE ASSURANCE COMPANY, COLONIAL LIFE & ACCIDENT INSURANCE COMPANY, HIGHMARK INC, HDI GLOBAL SPECIALTY SE (LLOYD'S OF LONDON), and UNITED OF OMAHA LIFE INSURANCE COMPANY to pay Medical, Dental, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, and Hospital claims incurred under the terms of the plan. The total premiums paid for the plan year ending 06/30/2021 were \$10,355,505.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 06/30/2021, the premiums paid under such "experience-rated" contracts were \$9,052,038 and the total of all benefit claims paid under these contracts during the plan year was \$7,061,588.
